



All the business license holders under the Trongsa Region are requested to report for the renewal with your original licenses and valid tax clearance certificate (TCC), in person. However, if the license holders are not able to report by themselves for renewal, they are required to send the information viz. no. of person employed, scale of their business, status of business, ICT usage by the enterprise along with the above documents through representatives. The service and manufacturing industries license holders issued with the Environmental Clearances (ECs) are **required to pay EC renewal fees** and are required to produce valid ECs during renewal. The MTRC (micro trade registration certificate) issued in 2014 should also report for renewal and retail and wholesale license holders are requested to check the validity of their licenses and report for renewal along with their TCC and a copy of citizenship identity card, accordingly. The last date for the renewal of licenses is June 30, 2017.
