## Issues discussed:

1. Specification for solar panel for street lighting system

The Bhutan Vision raised the issues on the rating of solar panel having 100 Wp, 18v. On this, the offtg. CE clarified that the 18 V here is the open circuit voltage. The actual rating is 100Wp, 12V.

2. Final destination/delivery for the solar system.

The Bhutan Vision also raised the issues on final destination/delivery of the solar system and whether the lot is only for supply or for installation works also. The Project Manager clarified that the systems are to be delivered to DRE store, Thimphu and hence there aren't any installation works.

3. Make of the solar street lighting system

The Charis Enterprise representative inquired about the make of the solar street lighting system. To this, the offtg. CE explained that we cannot ask or specify for the make and we don't restrict for any make but the suppliers can refer the technical specifications given in the tender document and accordingly submit their offer.

#### 5. Solar street light pole.

The offtg. CE briefed the floor on requirement of solar street light's pole to provide at least 3 folds in order to have easy transportation addition to the specifications given in the tender document. He also explained on the need of standard diameter of the pole to withstand the system.

#### 6. Minutes of Pre-bid meeting

The offtg. Chief Engineer also requested the floor that the Minutes of Pre-bid meeting is necessary and prerequisite to be attached with the bid during the time of submission. If the Minutes of Pre-bid meeting is not submitted along with the bidding document, it will be considered as non-responsive and the bid shall be rejected.
