- 6. Medical Certificate; and
- 7. Certificate of mandatory integrity test.

The applicants shall be shortlisted based on BCSR 2023 and only the shortlisted applicants would be informed. The selected candidates shall be required to submit No Objection Certificate from the Parent/Working Agency.
