Terms of Reference

- 1. The selected candidates shall be hired as Enumerators for the tentative period of six days (November 18-24, 2025 tentative), mainly for Data Collection, including a training period. The survey period may be extended or reduced.
- 2. The Enumerators shall undergo one-day training in Thimphu on November 18/19, 2025 -tentatively
- 3. The Enumerators shall coordinate and cooperate with Supervisors to plan interviews;
- 4. The Enumerators shall conduct face-to-face interviews with respondents;
- 5. The Enumerators shall assist the Supervisor and Research Coordinators to update work progress and support the supervisor wherever necessary.
- The Enumerators shall perform any other tasks, such as arranging interviews and carrying out research-related work, as may be assigned by the Supervisor and Research Coordinators;
- 7. The Enumerators will have to bear expenses related to their accommodation and food.
- 8. The documents for selected candidate(s) shall be verified, and any incomplete information or documents will not be considered, and the applicant will be disqualified; and
- 9. In the case of selected candidate(s) not turning up or candidate(s) disqualified during verification of documents, the vacant post will be filled from the pool of candidates identified as stand-by, and the next candidate if a stand-by is not available.

Renumeration/Benefits:

- 1. The enumerations shall be paid Nu. 1250 per day during field data collection only;
- 2. An amount of Nu. 400 per day, and a working lunch shall be provided during the training period.
- 3. Upon successful completion of the task, the DoW may consider issuing a Letter of Participation on the recommendation of the Supervisor and Research Coordinators.
