The Ministry of Energy and Natural Resources is pleased to re-announce the vacancy for the post of Chief Engineer on Secondment or on Contract to Punatsangchhu-I Hydroelectric Project Authority (PHPA-I) as follows:

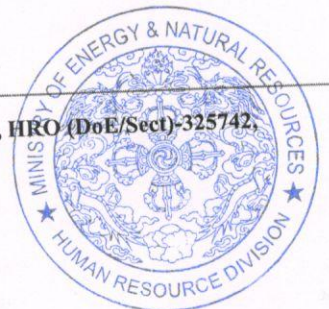

Chief Engineer (Contracts)	Minimum of Bachelor's Degree in Civil/ Electrical/ Mechanical Engineering from any recognized university/ institute.	3 years from the date of joining or dissolution of the Project Authority, whichever is earlier.	1

**Eligibility Criteria:**

The minimum eligibility criteria are as follows:

1. Minimum 15 years of experience in execution of large infrastructure projects, preferably in hydropower projects, of which at least 5 years of experience should be in tendering and contracts of civil works of such projects.
2. Position Level: At senior management level (P1A in the civil service and Sr. Manager and above or equivalent position in corporations).
3. Age: Maximum fifty-seven (57) years of age as of the last date of application submission specified in the announcement.
4. Other criteria: Has a clean service record with i) no outstanding dues, audit memos or administrative penalties; ii) no pending administrative disciplinary cases;
5. Additional criteria for civil servants:
  - a. Have completed a minimum of 2 years of active service in the current position in the Agency for the candidates appointed and promoted through open competition as per the section 11.7.4 of the BCSR 2023
  - b. Applying for Secondment for the first time, and
  - c. Not a contract employee.

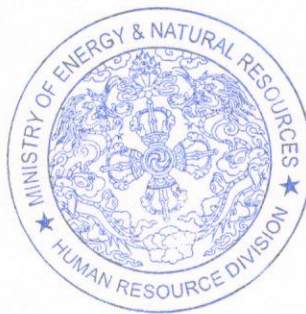
